Sutton County Overview Report

Population

Total county population in 2007 for Sutton County: 4,303, up 0.6 percent from 2006. State population increased 2.1 percent in the same time period.

Sutton County was the state's 207th largest county in population in 2007 and the 124th fastest growing county from 2006 to 2007.

Economy and Income

Employment

April 2009 total employment in Sutton County: 3,681, up 10.1 percent from April 2008. State total employment increased 0.3 percent during the same period.

April 2009 Sutton County unemployment rate was 5.7 percent, up from 1.8 percent in April 2008. The statewide unemployment rate for April 2009 was 6.7 percent, up from 4.6 percent in April 2008.

Income

Sutton County's ranking in per capita personal income in 2006: 50th with an average per capita income of \$31,947, up 15.6 percent from 2005.

Statewide average per capita personal income was \$35,166 in 2006 up 5.8 percent from 2005.

Industry

Agricultural cash values in Sutton County averaged \$22.7 million annually from 2004 to 2007. County total agricultural values in 2007 were down 34.9 percent from 2006. Major agriculture related commodities in Sutton County during 2007 included:

As of 2007, property values in Sutton County: \$1,995,373,645, up 5.2 percent from 2006 values.

The property tax base per person in Sutton County is \$463,717, above the statewide average of \$78,684.

About 54.1 percent of the property tax base is derived from oil, gas and minerals.

State Expenditures

Sutton County's ranking in state expenditures by county in state fiscal year (FY) 2008: 222nd. State expenditures in the county for FY 2008: \$13,704,629, up 18.8 percent from FY 2007.

In Sutton County, 6 state agencies provide a total of 47 jobs and \$2,086,228 in annualized wages (as of 4th quarter 2008).
